We are proud to announce that EST Sourcing, on behalf of MaxProf, has now officially recruited 2 new interns for the six months internship programme commencing 1 July 2022. As a business that is operating in a diverse community and country at large, it is imperative for MaxProf to run a programme that is inclusive of all young people. This internship programme is specifically for youth living with disabilities, that will assist them in jump-starting their professional careers and ensuring that they are well prepared for the workplace. The learnership entails a 6-month course offered online by a SETA accredited training provider, Connect The Dots.

As per the previous year, the course is a **Higher Certificate in Making the Transition as a Graduate/School Leaver to the Workplace**, which is customized and aligned to MaxProf's operations. This course will run concurrently

while the students receive on-the-job training. They will have classes and be expected to complete all the Unit Standard's Portfolio of Evidence and assignments weekly with the support of their facilitators.

The interns will accompany auditors on client visits to assist and learn about the duties of a specialised VAT auditor. Their main functions will entail compiling documentation required to conduct a review, scan invoices to assist with SARS claims, as well as organising documents accordingly.

The two new interns are Ms. Leandra Apollis and Mr. Kamogelo Tladi who are excited to start their journey at MaxProf. We wish them well!

As we made our journey through the meandering N2 route in the Eastern Cape along the Kei Tuckings Mountains, we left Buffalo City Metropolitan Municipality in the early hours of the morning. The auburn sunrise led us through the misty and cold Kei River region where we stopped for a hot coffee to awaken us for the Amathole District Municipality State of the District Address (SODA).

While at the top of the mountain, one could not ignore the sparsely placed corrugated metal roofs surrounded by evidence of subsistence farming. It was a deafening reminder of the reality that our bursary recipients are living in their hometown. Upon arrival at the Mbashe Local Municipality Council's Chamber, a briefing session was conducted, and all esteemed guests were

treated to a selection of refreshments and snack platters to break the fast before the Amathole District Municipality SODA. Rev. Mkentane, the Amathole District Municipality Chief of Staff outlined the proceedings of the bursary handover to EST Sourcing and MaxProf before we rushed over to King Hintsa FET College to set-up all branding aids as per the District's guidelines. We partnered with Amathole District Municipality to nominate students within the district for an opportunity to study a course of their choice.

The office of the Mayor included EST Sourcing's bursary handover in the programme to recognise the effort to eradicate youth unemployment and increase their employability skills by enrolling disadvantaged youth in accredited institutions.

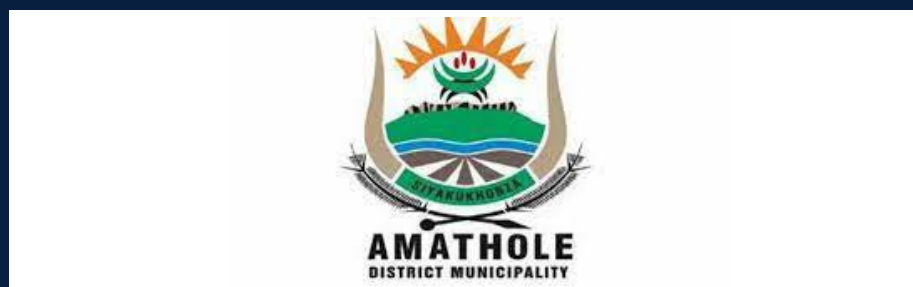

Municipal Manager, Mr. Disang Molaole and the District Councillors all took time out of their busy schedules to encourage the students to work hard, compete with oneself to build a better future and not to allow their backgrounds to determine the path their lives take. YOUTH DAY AND EST SOURCING'S FIRST ANNIVERSARY CELEBRATIONS

EST Sourcing celebrated its first anniversary and Youth Day by showing appreciation for the youth that have given us purpose. Bursary recipients from all over the country shared their gratitude in a short video montage that we were able to share across all our social media platforms. Although not all EST Sourcing recipients could be included in the video, the realisation that these are real people that are genuine and ecstatic to have an opportunity to study further and gain valuable skills, is humbling.

EST Sourcing has also extended its operations into an additional region, KwaZulu-Natal,

specifically to the Amajuba District Municipality. This project was unprecedented due to the students needing ease from their tuition debt. It shed light on the many challenges the youth in South Africa face daily. Some students may qualify to register and complete a qualification.

However, they may not be able to graduate and make use of the diploma or degree due to outstanding debt that may have accumulated throughout their course. A total of 14 students from Majuba FET College were assisted; of the 14 candidates, 6 are studying Engineering Studies, 7 are studying Business Studies and 1 student is studying Animal Production.

VAT ON SECOND-HAND GOODS

A VAT VENDOR CAN CLAIM AN INPUT TAX DEDUCTION ON SECOND-HAND GOODS PURCHASED FROM A NON-REGISTERED VENDOR

What is Notional VAT?

Company A who is a VAT Vendor is entitled to claiming an input tax deduction on purchases of second-hand goods acquired from Mr. B who is a non-registered VAT vendor. The VAT Act allows Company A, a notional tax deduction (15/115 of the purchase price) provided that certain requirements are met.

“Second-hand goods”

The first requirement would be to ascertain whether the goods in question meet the definition of second-hand goods as defined by the Act. Section 1(1) of the VAT Act, defines second-hand goods as, “goods which were previously owned and used”, but not including

- Animals
- Gold coins issued by the Reserve Bank in terms of section 14 of the South African Reserve Bank Act

Claiming the Notional deduction

When claiming the input tax deduction, a VAT264 form must be completed by both the purchaser and the seller. The following records must also be retained:

- The name and address of the person who sold the goods (Mr. B)
- As verification of his name, his identity number, or if the purchase is R1000 or more, a photocopy of his identity document

- Where the seller is not a natural person, the company’s or close corporation’s name and legally allocated registration number with reference to its business letterhead or other similar document and the identity number of its representative. Where the supply is R1000 or more, photocopies of such letterhead or other documentation indicating the name and registration number, as well as a photocopy of the representative’s identity document

- The date of the purchase
- A description of the goods
- The quantity, mass, or volume of the goods
- The purchase price
- Proof of payment of the purchase price

In addition to the above, the notional deduction can only be claimed by a vendor who is a resident of South Africa.

How much should be claimed?

The deduction should be claimed at 15/115 x (the lesser of the open market value and the consideration). It is important to note that the deduction is allowed up to the extent that payment for the supply has been made, as per Section 16(3)(a)(ii) (aa) of the VAT Act.

Example 17 – Limitation of notional input tax to the extent of payment of the consideration

Facts:

A second-hand goods dealer buys a used fridge from a non-vendor for R600 for resale. He pays the person R400 immediately and the balance of R200 in the next tax period.

Result:

Input tax is calculated as follows:	R
Deduct in tax period 1 – $R400 \times 15 / 115$	= 52,17
Deduct in tax period 2 – $R200 \times 15 / 115$	= <u>26,09</u>
Total	= <u>78,26</u>

In conclusion, SARS` BGR43 must be consulted on more complex issues, as the above is a simple summary of complex legislation.
